The Income Tax Department invites applications from advocates experienced in direct tax matters for engagement as Special Public Prosecutor (SPP) to represent the Income Tax Department before Courts of Session and its subordinate Courts & other judicial fora in prosecution cases. 2. The term of engagement of Special Public Prosecutor shall be for a period of 03 years. The schedule of fees, eligibility criteria and other terms and conditions shall be governed by Instruction No. 02/2023 issued in F.No. 279/Misc./M-77/2011-ITI dated 30-11-2023 of the Central Board of Direct Taxes, New Delhi or any further instruction issued by the competent authority.

3. Eligible and willing advocates may submit their duly filled applications in the prescribed format (Proforma P1) in the Office of the Principal Chief Commissioner of Income Tax, Aayakar Bhawan, 47, Arera Hills, Narmadapuram Road, Bhopal or via email at bhopal.dcit.tech.pccit@incometax.gov.in by 27-02-2026 until 05:00 PM. 4. Qualifications for Special Public Prosecutor;
In order to be eligible for engagement as an Special Public Prosecutor, a person should:
(a) Be eligible to appear before the court as an advocate and
(b) Have a minimum experience of 7 years as a practicing advocate in criminal matters. Adequate experience of handling trials relating to Direct Taxes is desirable.

For the purpose of calculating experience as mentioned in CBDT Instruction No. 02/2023 issued in F.No. 279/Misc./M-77/2011-ITI dated 30-11-2023, the cut-off date for eligibility shall be the date of the current advertisement. Applications received before this advertisement or after the due date, are liable to be rejected. Applications found deficient in any respect shall also be rejected.
